This is a statement of Sci-Fi South Collectors Exhibitor/Dealer policy for the event at Fleming Park on 2nd July 2011. Please read carefully before signing and keep a copy for your records.

1. Sci-Fi South Collectors agree to provide the Exhibitor/Dealer (you) with the number of tables required for the fee stated on sheet 1 of this booking form.
2. The Exhibitor/Dealer agrees to pay in full to secure their table booking for 2nd July 2011. **Full payment is to be returned with this Exhibitor/Dealer application form to secure their table booking by 1st may 2011.**
3. Post dated cheques will not be accepted as payment.
4. Refunds will only be given if requests are submitted in writing by 11th June 2011
Please note: A fee will be charged for a cancellation by Exhibitor/Dealer at 20% of Dealer/Exhibitor full booking total.
4. The Exhibitor/Dealer agrees that if they have not occupied their reserved table space by 9.30 am on 2nd July 2011, and have not informed Sci-Fi South Collectors staff of late arrival, that Sci-Fi South Collectors staff may offer their table to other exhibitors/dealers without refund to the absent Exhibitor/Dealer.
5. The Exhibitor/Dealer agrees that Sci-Fi South Collectors, its organisers and its volunteers, shall not be held responsible for items lost, stolen or damaged during the day of 2nd July 2011.
6. The Exhibitor/Dealer agrees to keep the assigned area clean, dispose of litter and be responsible for any damage caused by the Exhibitor/Dealer.
7. Tables are to remain in the specified space and configuration as placed by Sci-Fi South Staff. Minor changes must be agreed by Sci-Fi South's Dealer Liason, Melanie Clive, which in most cases can be accommodated but this is purely at the discretion of Sci-Fi South Management.
8. The Exhibitor/Dealer agrees to display and/or sell merchandise, which is consistent with all International and UK copyright and trademark agreements and standards. No responsibility is accepted by Sci-Fi South Collectors for any merchandise sold and remains sole responsibility of the Dealer.
9. The Exhibitor/Dealer agrees that any violation or breach of this agreement may result in the cancellation of this agreement and forfeiture of the Exhibitor/Dealer's leased space without refund.
